Policy Resolution 1: Fleet Size Splits

Submitted by Anna Burnett (GBR)

Proposal: A mandatory split of fleets at 40 entries.

Reason: Olympic fleet size is close to 20 so the split fleet at 40 is in line with this style of racing. More than 40 boat fleets is very challenging with the 30 minute time limit because the line has to be very long but we can't increase the course size to retain the correct geometry.

Young/new teams with less experience may have less chance to learn from the racing with the + 40 boat fleet because the front to back fleet spread is huge. The race with + 40 boats is very often decided in the first 30 seconds/start because the leverage of the long line is huge.

The smaller fleet racing keeps us in line with the 49er/FX so makes following the championships more understandable for those with an interest to watch.

Windy/top end conditions present safety challenges with the coming together of upwind/downwind boats as the big fleet gets quite spread out. This is less of an issue with the smaller fleet size.
